**Eligibility:**

Amateurs who are members in good standing of the USCTA and have attained age 60 prior to or during calendar year 2010 are eligible.

**Match rules:**

**All entrants must be members in good standing of the USCTA.**

USCTA rules will govern and the 15-minute default rule will be in effect. All players must be prepared to play at noon, Thursday, March 25, 2010. Depending upon the size of the draw, we may be able to begin on Friday.

Proposed format (governed by USCTA rules adopted 8/15/03):

- Semi-final and finals matches are to be two of three, six game sets, with games played to deuce and advantage.
- No more than two rounds per day (including semis and final matches).
- Earlier rounds may be played to 40-all (2 of 3 six game sets).
- Preliminary rounds may consist of one ten game set with deuce and advantage.

**Entry and Guest Fees:**

\$150 per player – 1<sup>st</sup> event

\$ 75 per player – 2<sup>nd</sup> event

\$ 30 per guest, per day (includes continental breakfast, luncheon, non-alcoholic beverages, and snacks). Host must sign for alcoholic beverages.

If your guest attends the Friday cocktail and dinner party, add \$50 to the daily guest rate for a total of \$80.

**Included** (for entrants and paid guests):

- Coffee, tea, and snacks (Fri, Sat, Sun).

- Framed 2010 US 60s group photo (for entrants only).
- USCTA medals for Champions and Finalists – compliments of all USCTA member clubs.

Thursday and Saturday dinners are **not** included in entry fees. Since some players may not arrive until Friday and some may not be able to stay for Saturday dinner, both dinners will be “Dutch Treat” at local restaurants.

**Payment of entry fees:** Entry fees and guest fees are due prior to close of entries on Friday, March 19. Fees may be paid by check payable to “**National Tennis Club**”, cash, credit card, or by charge to a home club of which you are a member in good standing. If you choose the “charge to your club” option, please designate your club on the entry form and initial to approve the charge of entry and guest fees against your home club account.

**Deadline for refunds:** All entry and guest fees will be non-refundable after the draw is posted on the USCTA website (**uscta.org**) at 12:00 pm, Monday, March 22, 2010.
