**Tickets will officially go on sale Friday, February 26th, 2010 at 9:00am EST.**

Once the system is live we anticipate strong demand and therefore encourage interested parties to act quickly. **Seats will be reserved on a first come, first served basis according to the timestamp indicated on your email request.** All ticket requests must be emailed to World Championship Committee Member Josh Bainton: [josh@pdqri.com](mailto:josh@pdqri.com).

Your email request must indicate the following:

1. The number of seats you want to purchase - please rank order your preferences of seat location (e.g., dedans, side gallery, upper gallery).
2. Your home club and account number for billing purposes.
3. Whether or not you wish to participate in the amateur handicap round robin (see details below).

Orders received before 9am will not be honored.

You will be sent confirmation of your purchase within one day and will be billed accordingly. Tickets will be charged to your home club. In the event this form of payment is not applicable credit card information must be provided (your seat will not be guaranteed until payment is confirmed).

Below is a breakdown of ticket prices and seat locations; please understand that each ticket reserves a particular seat for **all four days** of the Final Eliminator and associated exhibitions, including:

Friday March 19<sup>th</sup> at 5pm – Tennis & Rackets Exhibitions  
Saturday March 20<sup>th</sup> at 2:30pm – 4 Sets  
Sunday March 21<sup>st</sup> at 12:30pm – Remaining Sets

### **Ticket Prices:**

*Dedans:	\$500.00 (includes all 4 days) (25 available seats)
Side Gallery:	\$300.00 (includes all 4 days) (26 available seats)
Grille:	\$300.00 (Includes all 4 days) (2 available seats)
Upper Gallery:	\$200.00 (Includes all 4 days) (56 available seats)

\*Exact seat location in the dedans will be determined by subsequent auction: After the dedans sells out those who purchased dedans seats will be sent an email with instructions on how to participate in the auction, to be held at a date TBA. Dedans purchasers are guaranteed a seat in the dedans even if they elect to opt out of the auction.

### **Eliminator Round Robin:**

There will be a handicap doubles round robin for those inspired by the world's best tennis who wish to get their game on. Space is limited and will be determined on a first come, first served basis. Players are guaranteed multiple matches. Players **MUST** be available to play starting at 9am Friday through Sunday morning. Cost is \$100.

### **Schedule of events:**

**Thursday:** Cocktails and heavy hors d'oeuvres will be served beginning at 6pm and available throughout and after the match. The Final Eliminator begins at 7:30.

**Friday:** Breakfast and lunch will be served at the tennis house. Round Robin matches will be contested from 9am – 5pm. The bar opens at 11. At 5 there will be a court tennis doubles exhibition match featuring Tim Chisholm, Josh Bainton, Richard Smith, and Bryn Sayers, followed by a doubles rackets exhibition match featuring Guy Devereux, Jonathan Larken, Tim Chisholm and Neil Smith. The USCTA is sponsoring a cocktail party. Afterwards a casual dinner will be served at the main clubhouse.

**Saturday:** Continental breakfast followed by a pre-game lunch at the tennis house. The Eliminator Match resumes at 2:30. Round Robin matches will be played before and after the big event. Cocktail party immediately following the match and resuming in the main clubhouse bar at 7. The World Championship Gala begins at 8 in the main clubhouse.

**Sunday:** Brunch will be served at the tennis house starting at 10. The finals of the Round Robin will be held. The completion of the Eliminator Match begins at 12:30. The weekend concludes with a champagne reception with the contestants.
